

Société de la Tour Eiffel increase committal to sustainable real estate

Following its undertaking and activity in relation to the Grenelle ecological movement, Société de la Tour Eiffel confirms having signed the **energy efficiency charter for public and private office property**, as initiated by the Housing Minister Cécile Duflot and the Ecology and Energy Minister Philippe Martin, under the aegis of the sustainability building plan.

The Company was among the first to make this undertaking, together with a number of other operators with a view to promoting « a common movement towards improving energy efficiency, occupier well-being and economic activity in the construction and real estate industry ».

Inclusion in the Novethic index and GRESB Survey recompensed by an EPRA bronze award

This commitment follows in the wake of numerous previous environmental initiatives. A founding member of the Sustainability Observatory, the Company's action has been recompensed in 2013 by an EPRA Bronze award and by a first inclusion in the Novethic index as well in the GRESB Survey. This places the Company amongst the leaders in sustainability, qualifying for the B+ level on the GRI grid.

A quoted SIIC on the Paris Euronext market, Société de la Tour Eiffel holds and manages a commercial real estate portfolio valued at € 800 millions for close to 500.000 m².

More than 60% of the portfolio is less than 10 years-old whilst some 30% is certified *Haute Qualité Environnementale*. Regular disposals contribute to portfolio optimization whilst delivering improved economic and environmental performance.
