

Société de la Tour Eiffel leases 4,000 m² on its Eiffel business park of La Défense-Nanterre-Seine (69,000 m²)

Continuing on from the first semester of 2018, during which 6,000 m² of office space were let, Société de la Tour Eiffel has announced the signing of new leases representing more than 4,000 m² on its Eiffel business park of La Défense-Nanterre-Seine. The business park for light industrial and offices with 69,000 m² is located close to a large number of transport facilities (A86 motorway, regional express railway (RER A line at the Nanterre University station, T2, etc.) and the leading European business centre of La Défense.

Since its acquisition by Société de la Tour Eiffel in late 2016, the park has been subject to major renovation schemes and the restructuring of the existing buildings, during which time the company has deployed a number of complementary services for the benefit of its tenants (catering, fitness centre, nursery, security control room, etc.). Thanks to this dynamic management, the park's occupancy rate has significantly improved to reach 80%.

Navarque, which benefits from a wooded environment and a distinctive architecture along the banks of the Seine, as well as several terraces and car parks, will be BREEAM-RFO certified with a "Good" rating.
